

### **Treasurers' Report – Mike Corbett – June 28, 2023**

The Saint John Regional Chamber of Commerce's financial goal is to ensure sustainability, growth, and financial security. Success in these goals allows the Chamber to provide services that increase value for you, the members.

With Covid in the rearview mirror, 2022 was a more normalized fiscal year. That being said, The Chamber, as well as our members, continue to face many financial challenges that require tremendous effort and resourcefulness. As we find our place in the new-normal, we are able to celebrate the fact that the business community was able to overcome and succeed.

Traditionally, our main revenue streams are Memberships and Special Events. As of fiscal 2022, we were once again able to return to offer events that bring value to our members. We were pleased to see the business communities continued support of our efforts by excellent event attendance, strong Membership Renewals, and the addition of new members.

Our external auditors, Teed Saunders Doyle, have completed an audit of the 2022 financial statements and have issued an unqualified audit opinion.

As per our December 31<sup>st</sup>, 2022 year-end financial statements, the Chamber essentially experienced a breakeven year with a surplus of \$3K. Our operational loss position was \$-2K, but thanks to the last of the wage subsidies and investment income, we were able to end the year in a positive position.

Throughout 2022, we maintained strong Membership Dues collected and saw an increase in Special events. This increase is, as per Note 8 in our year-end statements, primarily a result of Special Programs such as Shop/Lift Up Local, Rapid COVID Testing for Businesses, and Workcation.

The Chamber, at the end of the fiscal year, had cash and investments of approximately \$490K. Of this amount, \$40K is internally restricted to ensure the financial stability of the organization. The remaining funds are unrestricted and available to the organization for its general operating needs and assist in its ability to continue representing the business community in the Greater Saint John Region.

We as the Chamber will need to continue to practice strong fiscal restraint in our operations and find new revenue streams to assist us in our efforts for growth in the Saint John Region. We must ensure that we can remain an active and viable voice for our membership. The days ahead will still require strong financial management, but we are confident that we are up to the task.
